The review meeting on DMF to monitor the progress was held on 7.12.2017 under the Chairmanship of Sri Anupam Saha, IAS, Collector, Koraput at 11.00 am in Sadbhabana Sabha Gruha, Koraput. The list of members present in the meeting is enclosed in Annexure-I.

At the outset, Collector-cum Chairperson welcomed all members present and asked PD DRDA to appraise on proposal submission status on the Annual action plan for the financial year 2017-18. In addition, Collector instructed all executing agencies to prioritize their project list out of the Annual Action Plan-2017-18 and submit the project list along with estimates to PD DRDA cum Chief Executive of DMF for sanction of the projects. The above process shall be completed by 15.12.2017 positively.

Afterwards PD DRDA cum CE DMF presented the progress of works under DMF since 2015-16 to 2017-18. As on date, Rs. 35.72 crores has been sanctioned out of which Rs. 27.60 crores has been released & Rs. 20.85 crores has been utilised, which was ascertained from the MPR received from all executing agencies. - All agencies are to submit their compliance reports after receipt of the proceeding within 3 days of receipt of the proceedings.
- All Projects must contain a Display Board of terracotta colour background and white coloured write up in both sides containing detail information. The size is 3 ft (width) x 4 ft (height).
